MINUTES**

The Greene County Quorum Court held its regular meeting Tuesday, February 21, 2023, in the Circuit Courtroom on the second floor of the Greene County Courthouse with County Judge Rusty McMillon presiding. The following were in attendance: Justices Sherma Clark Dicus, Robby Glasco, Bill McCartney, Jonathon Davis, Michele Boling, Phillip Keeling, Allen Davis, Dean Wooldridge, Marc Reeves, Ronnie Roberts and Clint Harris.

The meeting began with the Pledge of Allegiance led by County Judge Rusty McMillon and prayer led by Justice Allen Davis.

Justice Marc Reeves made a motion and Justice Robby Glasco seconded to amend the minutes of the January 17, 2023, meeting. The motion was approved.

Justice Ronnie Roberts made a motion and Justice Dean Wooldridge seconded to accept the minutes of the January 17, 2023, meeting. The minutes were accepted.

Justice Robby Glasco made a motion and Justice Bill McCartney seconded to read a Resolution titled "**A RESOLUTION TO SUPPORT DEVELOPMENT OF THE PARTNERSHIP FOR BRIDGE NEA'S APPLICATION FOR U.S. DEPARTMENT OF TRANSPORTATION ACTIVE REGIONAL TRANSPORTATION AND NEIGHBORHOOD EQUITY IN GREENE COUNTY AND CRAIGHEAD COUNTY AND PROVIDE A LOCAL FUNDING TO MATCH A USDOT RAISE GRANT OPPORTUNITY, AND FOR OTHER PURPOSES.**" The motion carried. The Resolution was read by Attorney Kimberly Dale. Justice Jonathon Davis made a motion and Justice Robby Glasco seconded to approve. The motion carried. The Resolution was passed 8-3 with Justices Robby Glasco, Bill McCartney, Jonathon Davis, Michele Boling, Phillip Keeling, Allen Davis, Dean Wooldridge, Marc Reeves voting in favor, and Justices Sherma Clark Dicus, Ronnie Roberts, Clint Harris voting against.
