The Greene County Quorum Court held its regular meeting Monday, September 18, 2023, in the Circuit Courtroom on the second floor of the Greene County Courthouse with County Judge Rusty McMillon presiding. The following were in attendance: Justices Sherma Dicus, Robby Glasco, Bill McCartney, Jonathon Davis, Michele Boling, Phillip Keeling, Allen Davis, Dean Wooldridge, Marc Reeves, Ronnie Roberts, and Clint Harris.
