MINUTES**

The Greene County Quorum Court held its regular meeting Tuesday, January 16, 2024, in the Circuit Courtroom on the second floor of the Greene County Courthouse with County Judge Rusty McMillon presiding. The following were in attendance: Justices Sherma Dicus, Bill McCartney, Jonathon Davis, Phillip Keeling, Allen Davis, Dean Wooldridge, Marc Reeves, Ronnie Roberts, and Clint Harris. Justices Robby Glasco and Michele Boling were not present.

The meeting began with the Pledge of Allegiance led by County Judge Rusty McMillon and prayer led by Justice Ronnie Roberts.

Justice Phillip Keeling made a motion and Justice Marc Reeves seconded to accept the minutes of the December 11, 2023, meeting. The minutes were accepted.

NEW BUSINESS-

Justice Ronnie Roberts made a motion and Justice Marc Reeves seconded to accept **THE APPOINTMENT OF BOBBY HODGE TO THE NORTHEAST GREENE COUNTY FIRE DISTRICT COMMISSION.** Passed with a vote of affirmation with all in favor, none opposed.

Justice Bill McCartney made a motion and Justice Dean Wooldridge seconded to accept **THE REVISION OF GREENE COUNTY PERSONNEL POLICY, SECTION 2.7–NEPOTISM TO ADD “or hiring” IN THE FIRST SENTENCE AFTER “An elected”.** Passed with a vote of affirmation with all in favor, none opposed.

Justice Sherma Dicus made a motion and Justice Dean Wooldridge seconded to suspend the rules and put an Ordinance titled **"AN APPROPRIATION ORDINANCE TO AMEND GREENE COUNTY ORDINANCE 2023-25"** on its first reading by title only. The Ordinance was read, title only, by Attorney Kimberly Dale. Justice Phillip Keeling made a motion and Justice Allen Davis seconded to accept the Ordinance as Read. The motion carried.

PUBLIC COMMENTS (FOR ITEMS NOT ON THE AGENDA) – None.

Justice Dean Wooldridge made a motion and Justice Marc Reeves seconded to adjourn. The motion carried and the meeting was adjourned.
