NOVEMBER 13, 2023
MINUTES**

The Greene County Quorum Court held its regular meeting Monday, November 13, 2023, in the Circuit Courtroom on the second floor of the Greene County Courthouse with County Judge Rusty McMillon presiding. The following were in attendance: Justices Robby Glasco, Bill McCartney, Jonathon Davis, Michele Boling, Phillip Keeling, Allen Davis, Dean Wooldridge, Marc Reeves, Ronnie Roberts, and Clint Harris. Justice Sherma Dicus was not present.

The meeting began with the Pledge of Allegiance led by County Judge Rusty McMillon and prayer led by Justice Robby Glasco.

Justice Phillip Keeling made a motion and Justice Allen Davis seconded to accept the minutes of the October 16, 2023, meeting. The minutes were accepted.
